- A. Adoption of the 2019-2020 Opportunity Youth Academy Local Control Accountability (LCAP)

Background

Pursuant to Education Code (EC) 52068(b)(1), the Opportunity Youth Academy Governing Board held a public hearing to solicit recommendations and comments of members of the public regarding the specific actions and expenditures proposed to be included in the Local Control Accountability Plan (LCAP). This public hearing was held on June 25, 2019.

- B. Request Approval of the Revised 2018-19 and 2019-20 School Plan for Student Achievement (SPSA)

Background

California Education Code sections 41507 and 41572 require each school to consolidate all school plans for programs funded through the Consolidated Application and Reporting System, into the School Plan for Student Achievement (SPSA).

The Opportunity Youth Academy's School Site Council revised and approved 2018-19 and 2019-20 School Plan for Student Achievement to include updated budget information on June 20, 2019.

A. Performance Indicator Review (PIR) Plan 2018-2019

Background

Based on data for students with disabilities, as reported in the California School Dashboard and the Local Level Annual Performance Report (Annual Performance Report or APR), the California Department of Education (CDE) has determined that Opportunity Youth Academy will participate in the 2018–19 Performance Indicator Review (Performance Indicator Review or PIR) beginning in March, 2019.
