- * A. [Public Hearing Regarding Waiver Proposal](#)
On December 16, 2008 the County Committee approved a transfer of 13 parcels from Campbell Union and Campbell Union High School Districts to San Jose Unified School District. Per Education Code section 35709, the County Committee approval of a transfer of inhabited territory that does not have the consent of the affected districts constitutes an order of election. Under a general waiver request to the State Board of Education, a public hearing is required.

7. STUDY ACTION ITEMS

- * A. [Request Adoption of Resolution in Support of Senate Constitutional Amendment \(SCA\) 6 \(Simitian\)](#)
At the request of member Di Salvo, a resolution in support of Senate Constitutional Amendment SCA 6 (Simitian) is being brought to the County Board of Education for consideration. SCA 6 would allow local school districts to approve a local parcel tax with a 55 percent majority rather than the two-thirds majority currently required.

- * G. [Request Approval of Single Plan for Student Achievement \(SPSA\) in 2008-2009 and 2009-2010](#)
California Education Code sections 41507, 41572 and 64001 and the federal No Child Left Behind Act (NCLB) require each school to consolidate all school plans for programs funded through the School and Library Improvement Block Grant, the pupil Retention Block Grant, the Consolidated Application and NCLB Program Improvement into the Single Plan for Student Achievement (SPSA). The School Site Councils from the six Santa Clara County Office of Education schools developed and approved their SPSA. Administration recommends approval of the 2008-2009 and 2009-2010 Single Plans for student for the six SCCOE schools.
- * H. [Request Approval of Schoolwide Use of Funds 2008-2009 and 2009-2010](#)
Title I Schoolwide Program (SWP) authorization under Public Law 107-110, the No Child Left Behind (NCLB) Act of 2001 provides for the consolidation and use of Title I funds together with other federal, state and local funds if at least forty percent of the students are from low-income families and includes the ten components outlined by the California Department of Education. The SWP plans describe how each school will implement the components outlined in Components of a Title I Schoolwide Program and how Title I and other resources will be used for this purpose. Administration recommends approval to authorize a Schoolwide Program for the six SCCOE schools.
- * I. [Request Approval of 2008-2009 Consolidated Application, Part I](#)
The Consolidated Application (ConApp) is a two-part application and reporting process for multiple state and federal, formula-driven, categorical program funds. It is used by the California Department of Education (CDE) to distribute categorical funds from various state and federal programs to county offices, school districts and direct-funded charter schools throughout California. Programs included in the Santa Clara County Office of Education ConApp are the Peer Assistance and Review, School Safety and Violence Prevention programs, Title I, II, III, IV and V. Administration recommends approval of the 2008-2009 Consolidated Application, Part I.
- * J. [Request Approval of 2008-2009 and 2009-2010 Comprehensive School Safety Plan](#)
Per Education Code 35204.1(b)(1) and (2), the School Site Council shall develop a comprehensive school safety plan relevant to the needs and resources of that particular school or the School Site Council may delegate this responsibility to a school site safety planning committee. The 2008-2009 and 2009-2010 School Safety Plans for Santa Clara County Office of Education schools outline site specific safety programs and procedures required by Education Code Sections 32280 et seq. Administration recommends approval of the 2008-2009 and 2009 and 2010 Comprehensive School Safety Plans for SCCOE schools.
- * K. [Adoption of Aventa Online Curriculum](#)
Aventa Learning is one of the leading providers of online curriculum for middle and high school students. All courses are aligned with California standards and have met high standards through a curriculum review. Online courses combine text, graphics and multimedia to engage the learner and offer more complete lessons than print texts alone. Administration recommends adoption of Aventa Learning courses as an approved online curriculum.
